

St Johns Park Bowling Club – NRL Finals 2025
Trade Promotion – Terms & Conditions of Entry
Promotion Period: 23 September – 6 October 2025

1. This promotion is run by St Johns Park Bowling Club, 93 Edensor Rd, St Johns Park NSW 2176.
2. Open to financial members of St Johns Park Bowling Club who are aged 18 years and over. Directors, Management, Contractors and staff of St Johns Park Bowling Club Group are not eligible to enter.
3. Entry is via invitation link accessed through email, SMS or QR code. Entrants must provide their full name, membership number, phone number and email address. Multiple entries are permitted throughout the promotion period.
4. Incomplete, incorrect or automated entries may be deemed invalid. Entrants may be required to present valid ID to confirm eligibility. A person may only win one instant prize and one leaderboard prize during the promotion.
5. Player scores will be ranked on a live leaderboard. The top scorer at the end of the promotion period will win the first prize. In the case of a tie, the promoter reserves the right to split or reallocate the prize. If a winner forfeits, the next eligible player will be awarded the prize.
6. Winners will be contacted via SMS after the promotion ends. If a winner cannot be contacted or does not claim their prize within 7 days, the prize will be forfeited and awarded to the next eligible person.
